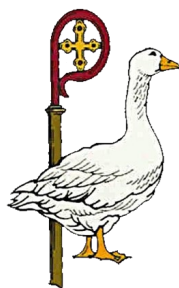

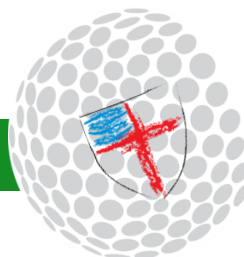
St. Martin's has had a relationship with the Diocese of Durgapur in West Bengal, India, since 2010.

The diocese currently serves over 300 children at 6 Child Development Centers that provide after-school programs including tutoring, enrichment activities, a substantial daily snack, and special holiday celebrations – all of which clearly make a difference in the lives of the children. These Centers serve children regardless of their religious affiliation. The majority of the children are, in fact, Hindu, Muslim or tribal, with relatively few Christians, yet all live and work together.

- * In 2010, St. Martin's raised \$20,000 to build a youth hostel in the leper community of Purulia, India. The hostel can provide shelter and meals for up to 40 children. The Child Development Center in Purulia serves 60 children from the community.
- * In 2012, St. Martin's raised funds to build an addition to the hostel, which now provides a large multi-purpose room used for classes, activities and programs, an enlarged kitchen, and 2 guest rooms.

- * St. Martin's and friends sponsor 38 children in the Centers. An annual fee of \$250 fee helps pay for school uniforms, books and supplies, food, academic tutoring, and access to computers.
- * In 2013, funds were raised to help establish an official sewing center in Purulia, which provides training for young women and girls. After their training they can be licensed and work as tailors elsewhere, or come back to the sewing center which is also a production shop.
- * In 2014, we funded the renovation of a donated building that is now the permanent home for the Purulia Sewing Center.
- * We've also done smaller projects including the purchase of umbrellas for all the children in the 6 Centers to protect them from both the brutal summer sun and the monsoons of India, and assistance to tribal villagers with micro-finance projects, training of health care assistants, livestock husbandry, and clean water.
- * We have visited our friends in the Diocese of Durgapur four times and we can attest to the financial responsibility of the diocese and its relevance to the critical needs of the community.

We hope you will join us in supporting the remarkable, life-changing work being done with the poor in this poverty-laden area of India.
